Amongst the key points of Chancellor George Osborne's Budget on 23 March 2011, Careers England welcomes these:

JOBS AND SKILLS

- 40,000 new apprenticeships for young people out of work
- Funding for 100,000 work experience placements

"In times of unprecedented unemployment amongst the under 25s, the additional opportunities which unemployed teenagers and young adults will be able to take is welcome news indeed" says Careers England, the trade association for specialist employers in the careers advice and guidance industry in England.

"We look forward to hearing more about how Ministers will ensure that all unemployed teenagers and young adults will receive the support they deserve and need to choose and access the most appropriate options from these new most welcome and needed opportunities".

"To bring success for those seeking work and training, it will be essential that careers advice and guidance is built into these plans as an essential pre requisite prior to entry, accessible during learning or training and on completion at transition to their next moves towards successful gainful employment."

"In respect of the new work experience provision, the need for everyone participating to be able to review outcomes from those experiences and to consider - with an independent expert careers professional - next moves, choices and plans must be assured to all who seek to take up new opportunities"

"We know too that it will be important for Ministers to work with employer organisations so that employers can be incentivised to recruit apprentices, and to offer work experience placements. The lack of employer involvement in opportunities for the unemployed has beleaguered too many government initiatives in recent times"
