Inspiring Careers: UK Careers Sector aims high despite spending cuts

National careers sector stakeholders have launched a forum to develop a UK-wide framework for all-age, all-stage career information, advice and guidance (IAG). Called the UK Careers Sector Strategic Forum, and chaired by Sir Martin Harris (Director for Fair Access), the Forum will galvanise and mobilise careers sector stakeholders around the themes of improving career management skills, access to career IAG services, delivering high-quality services, and improved national co-ordination of career guidance provision.

The UK Careers Sector Strategic Forum is being launched at a time when funding cuts loom. But the Forum strongly welcomes three reports published over the last few days to the extent that they have emphasised the increasing policy importance of career guidance:

- Lord Browne's Review of Higher Education funding stresses the importance of helping students make informed choices of what and where to study. It recommends that every school be required to make individualised careers advice available to its pupils. It further recommends that this advice should be delivered by certified careers professionals who are independent and whose status in schools is respected and valued.
- The Task Force on the Careers Profession chaired by Dame Ruth Silver makes 14
 recommendations designed to develop a strong careers profession and to reinforce a
 partnership approach based on provision within schools and support from an external
 service.
- 3. The Employer and Education Task Force calls for greater partnership working between employers and schools, in support of careers education programmes in schools.

Sir Martin Harris, Chair of the Forum and Director for Fair Access at OFFA, said: "The UK Careers Sector Strategic Forum will make an important contribution to career information and guidance provision at this crucial time for our country. Notwithstanding the difficulties we face from looming budget cuts, the Forum provides a collective voice for the Careers Sector to offer our young people and those at work a positive vision for accessing high-quality career support, in order to achieve their aspirations for learning, for work, and for making a contribution to our economy and society."

Professor Tony Watts, a leading international expert on career guidance, said: "The UK Careers Sector Strategic Forum will work assiduously to revitalise the role played by careers services at all stages of life, including all young people. Similar Forums are being set up in many European countries. The new Forum will link the UK into international networks as well as playing an important role within the UK itself."

Forum members will meet Government Ministers to discuss career IAG provision following the spending review to ensure that high-quality and independent provision remains a key policy priority.
